Extended warranties for replacement compressors



When compressors are replaced, they can either be remanufactured or rebuilt. Trane **only** offers remanufactured compressors, a more comprehensive and thorough process.

During remanufacturing, all components are tested to meet or exceed specifications before reassembly and final testing. This ensures that the new part is in the best possible condition when it is completed, which can extend the life of the equipment.

The rebuilding process, on the other hand, only replaces the defective components. This process may neglect to identify worn components which have not yet failed.

Optional Extended Parts and Labor Warranties are also available on the following products (see back for details on coverage).

Trane ReSpecT® compressor

The Trane ReSpecT compressor is the only remanufactured Trane compressor that meets the latest Trane OEM standards. The ReSpecT compressor comes with a standard two-year warranty and a first year system hazard warranty, excluding labor. The system hazard warranty provides a replacement compressor for the first operational failure during the first year. For the balance of the remaining two-year warranty, the compressor is covered by a replacement parts warranty, which provides parts or a replacement compressor (at the discretion of Trane) for a failure due to a defect in material or manufacture.

If purchased with the compressor, the labor warranty will also be honored on the first failure, regardless of cause.

Series 6000 compressors

The Trane, Carrier® and Copeland® Series 6000 compressors are remanufactured, and they come with a standard one-year replacement parts warranty. This standard warranty provides a replacement compressor if the compressor has failed due to a defect in material or manufacture.

If purchased with the compressor, the labor warranty will be honored if the compressor failed due to a defect in material or manufacture.

Trane helical rotary compressor

The Trane helical rotary compressor is sold with a standard one-year replacement parts warranty. This warranty provides parts or a replacement compressor (at the discretion of Trane) for a failure due to defect in material or manufacture.

If purchased with the compressor, the labor warranty will be honored if the compressor failed due to a defect in material or manufacture.

Optional warranties

Compressor parts warranty

If a part in the compressor covered by this warranty is defective in material or manufacture, this warranty will provide parts or a replacement compressor (at the discretion of Trane). The Trane ReSpecT compressor warranty is available for a 3-5 year term only. The Series 6000 (excluding Trane) and helical rotary compressor warranty is available for a 2-5 year term. Warranties are not available on any compressor that has been given in whole or part as a warranty replacement.

Optional compressor labor warranty

The labor warranty will cover repair or replacement labor including evacuation and cleanup for burnouts, actual technician travel time, reasonable time for system diagnosis and reasonable rigging and crane charges. The labor warranty is available with different maximum dollar limits. The Trane ReSpecT compressor labor warranty is available for a two-, twelve- or twenty-four month term. The Series 6000 and helical rotary compressor labor warranties are available for a one-year term.

The compressor labor warranty excludes repair or replacement of system controls, replacement or addition of refrigerant, per diem allowance and labor claims submitted on non-warranted compressor failures.

Contact your local Trane parts center to see if these warranties apply to your situation.

Conditions and exclusions

Extended warranties are available for purchase before the ship date of the applicable equipment. Warranty exclusions are as follows:

- Equipment repaired or altered in a manner which causes or materially contributes to the claimed defect (in the judgment of Trane)
- Corrosion, erosion or deterioration
- Damage due to accident, abuse, external causes (including controls) or freezing
- Crane charges, nuisance calls, freight and additional labor resulting from problem access areas
- Any charges caused by failure to perform Trane recommended maintenance and labor

The extended warranties are conditioned upon the equipment operating under normal use and service. Trane equipment should be installed following the space guidelines published in product literature. Warranty claims will be processed only after the product(s) and warranties have been paid in full or Trane has approved alternative credit arrangements. In no event shall Trane be liable for any special, consequential or incidental damages no matter under what legal theory advanced. Trane makes no other warranty express or implied.

In the event of a conflict or inconsistency between Trane literature and the extended warranty certificate, the terms and conditions of the certificate shall govern.
